## Ecological Impacts:

- RENEWABLE ENERGY (SOLAR Power):** -  
 The factory has its own Power supply from Solar Panels producing **52 kilowatts** of electricity which is directed to the National Power Grid. The factory has further plans to increase its solar panel capabilities.
- 52% OPEN SPACE WITH GREENERY AND PLANTATION:** -  
 The factory has more than half of its area left alone with Green Gardens & plantation giving an overall healthy and natural environment to both Project & its People.
- RE-CYCLE & RE-USE OF WATER:** -  
**RAINWATER HARVESTING:** - The factory has a 50,000 liters capacity rainwater harvesting tank which is mainly used in Toilets.



**STORM WATER RESERVOIR:** - The factory has a 185,000 liters capacity Storm water reservoir for support of firefighting.

- **WATER EFFICIENT FAUCET:** -  
All the toilets, basins & wash zone throughout the factory are having water efficient faucets to reduce water use and control wastage.
  
- **ENERGY EFFICIENT FIXTURE:** -  
The complete electrical fixtures of the factory are energy efficient LED lightings, auto sensor lightings in the Toilets & washrooms for a reduced power consumption at all time.

The designs & samples are prepared in house under highly skilled Pattern & CAD designer, Sample tailors to ensure a perfect & RFT (Right First Time) performance for all designs & samplings.

• **TRAININGS & ORIENTATIONS:**

All the employees are called upon with ample trainings at a random basis or case to case towards required Job. The company is also keen on implementing 5S for best performance within short time.

• **PRODUCT QUALITY:**

Factory is maintaining a high AQL 1.5 product quality for all buyers irrespective of their quality requirements with a vision for TQM (Total quality Management) or ‘Zero Tolerance’ for all the products.

• **FACE RECOGNITION ATTENDANCE:**

The attendance for all the employees is maintained through a Face detection system linked with ERP to avoid any error.

• **WORKER POLICY:**

Factory does not employ any child labour or force labour and do not discriminate in general with all employees.

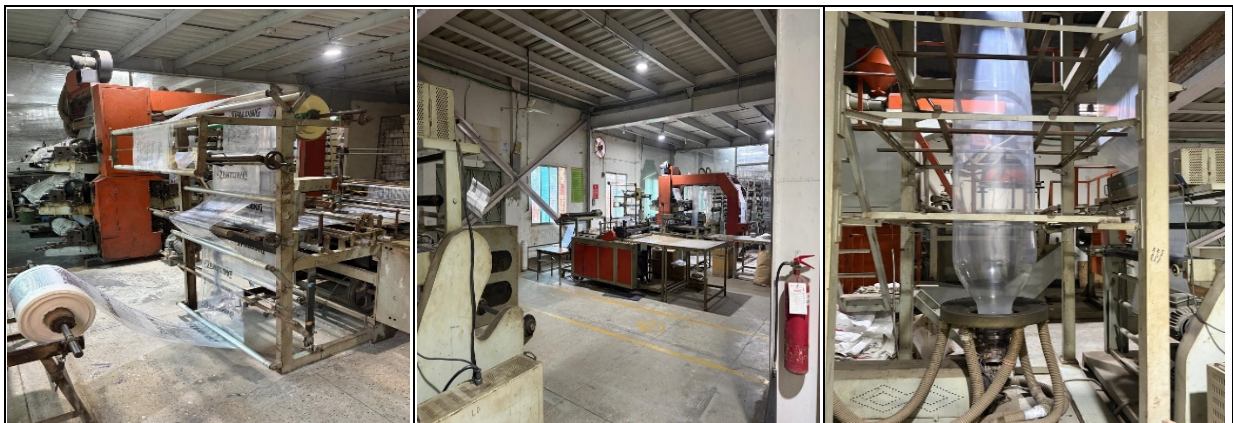

- **HIGHLY STANDARD WORKING ENVOIRNMENT: -**  
 The Company prioritizes robust structural safety, strict adherence to labor laws, occupational health protocols and fair treatment of workers

 The Company follows standard working hour, only 48 hours working per week in general for all employees. All the government holidays are also strictly followed as well.

 All the employees of the Company are paid better than the Least Declared salary scale of the Government & ILO within 4/5 workdays of the next month.
